

and agrees to bind its successors and assigns, to execute and deliver to The Longaberger Company, its successors and assigns, any further documents or instruments and to perform any further acts that may be deemed necessary to enable The Longaberger Company, its successors and assigns, to file the said applications for letters patent for the said invention in any country in which it may elect to file such applications, and to vest in The Longaberger Company, its successors and assigns, the title herein conveyed and intended to so be conveyed, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to The Longaberger Company, its successors and assigns; and it further binds itself and agrees to bind its successors and assigns, upon request, to communicate to The Longaberger Company, its successors and assigns, any facts relating to the said invention and the history thereof, known to Ozark Mountain Enterprises, Inc. or them, and to testify as to the same in any interference or other litigation when requested to do so by The Longaberger Company, its successors and assigns.


