**ASSIGNMENT**

WHEREAS, Shoichiro Asada, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled DISPLAY DEVICE AND SAMPLE ANALYSIS DEVICE EQUIPPED WITH THE DISPLAY DEVICE, executed by Assignor on the same date as this Assignment;

any such patent application or patent; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
