PATENT ASSIGNMENT AGREEMENT

FOR VALUE RECEIVED, and other due consideration, the receipt and sufficiency of which are hereby acknowledged, Ralph Tischler, having Canadian citizenship and a residence and mailing address of 1780 Lilac Drive, Surrey, British Columbia, Canada (hereinafter sometimes referred to as "ASSIGNOR"), hereby assigns, transfers and sets over to VTECH COMMUNICATIONS LTD., a Hong Kong corporation, having a place of business of 24/F., Tai Ping Industrial Centre, Block 1, 57 Ting Kok Road, Tai Po, New Territories, Hong Kong (hereinafter sometimes referred to as "ASSIGNEE"), ASSIGNOR' worldwide right, title and interest in and to the invention known as CORDLESS TELEPHONE HEADSET WITH DIALCARD DISPLAY, for which a Canadian Patent Application was filed on February 7, 2001, together with all rights and privileges under any Letters Patent which may be granted thereon, including all rights, if any, within and throughout the entire world to sue for all past infringements, which may have occurred before the execution of this Patent Assignment Agreement.


ASSIGNOR agrees, without charge to ASSIGNEE, but at ASSIGNEE'S expense (a) to execute (i) all necessary papers to be used in connection with the aforementioned application and any additional, continuing or divisional applications, as the ASSIGNEE may deem necessary or expedient, (ii) all papers in connection with any interference or other legal or quasilegal proceedings relating to the aforementioned application or any additional, continuing or divisional applications thereof; (iii) all papers and documents which may be necessary in connection with the preparation and filing of any foreign application or with making claims to priority rights granted under the provisions of the International Convention for the Protection of Industrial Property or similar agreements; (b) to cooperate with ASSIGNEE in every way possible in obtaining evidence and going forward in any such proceedings; and (c) to perform all other affirmative acts which may be necessary or desirable to obtain a grant of a valid patent for the design in any country throughout the world.

ASSIGNOR hereby authorizes and requests that the appropriate officials in any country issue any and all Letters Patent that may be granted upon any patent application or any additional, continuing or divisional applications thereof to the ASSIGNEE, its successors and assigns.

ASSIGNOR hereby covenants and warrants that he has full right to convey the entire worldwide right, title and interest by this instrument, free of any encumbrances and that no other agreement has been or will be executed in conflict herewith.

ASSIGNORS hereby grant to the LAW OFFICES OF DICK AND HARRIS of Chicago, Illinois, authority and power to insert on this instrument any further identification which may be necessary or desirable for the purposes of recordation in the Patent Office of the United States of America or the Patent Office of any other country.


