**Assignment**

WHEREAS, Reijo Jokinen, of Raisio, Finland (hereinafter "ASSIGNOR"), has invented a Blowing Apparatus in a Paper Machine or the Like, which was filed as PCT/FI00/00130 on February 21, 2000, and for which a corresponding application is being made for Letters Patent in the United States; and

ASSIGNOR hereby agrees that ASSIGNOR will similarly aid ASSIGNEE in the prosecution of any interference that may arise involving any application for Letters Patent herein contemplated and that ASSIGNOR will execute and deliver to ASSIGNEE any and all additional papers that may be reasonably requested by ASSIGNEE to fully carry out the terms of this Assignment.
