

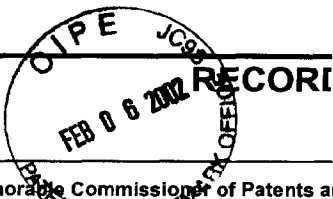

ASSIGNMENT

WHEREAS, Martin C. Bossler, a citizen of Germany, residing at 1913 Spring Dale Drive, Spring Grove, Illinois 60081 and Lucas Pai, a citizen of Taiwan, residing at 8F-2, No. 160, sec.1 Taijunggang Rd, Taichung 403 Taiwan, hereinafter referred to as ASSIGNOR, has invented and owns a certain invention entitled:

GAS BARBECUE WITH CART

for which application for Design Letters Patent of the United States has been filed on November 27, 2001 and assigned Serial No. 29/150,690; and

WHEREAS, Uniflame Corporation, a corporation of the State of Illinois, having a principal place of business at 1817 North Kenosha Road, Zion, Illinois 60099, hereinafter referred to as ASSIGNEE, is desirous of acquiring the entire interest in, to and under said invention and the United States Letters Patent to be obtained therefor:

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that in consideration of the payment by ASSIGNEE TO ASSIGNOR of the sum of One Dollar (\$1.00), the receipt of which is hereby acknowledged, and for other good and valuable consideration, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE the full and exclusive right, title and interest to said invention and all Letters Patent of the United States to be obtained therefor on said application or any continuation, division, renewal, substitute or reissue thereof for the full term or terms for which the same may be granted.

ASSIGNOR also assigns all of its rights, title and interest in and to said invention in all foreign countries, and all applications for Letters Patent which may evolve therefrom, including the right to claim International Convention priority.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent as may be known and accessible to ASSIGNOR and ASSIGNOR will testify as to the same in any interference or litigation related thereto and
