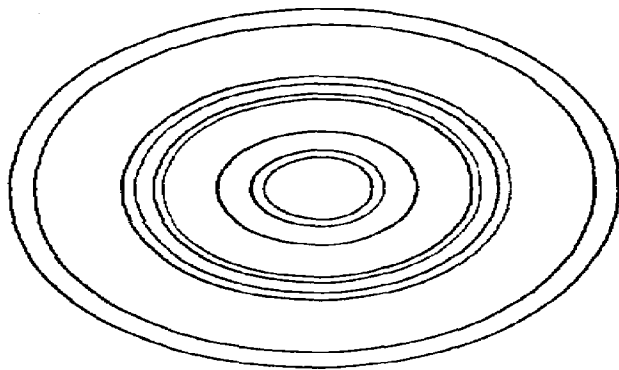

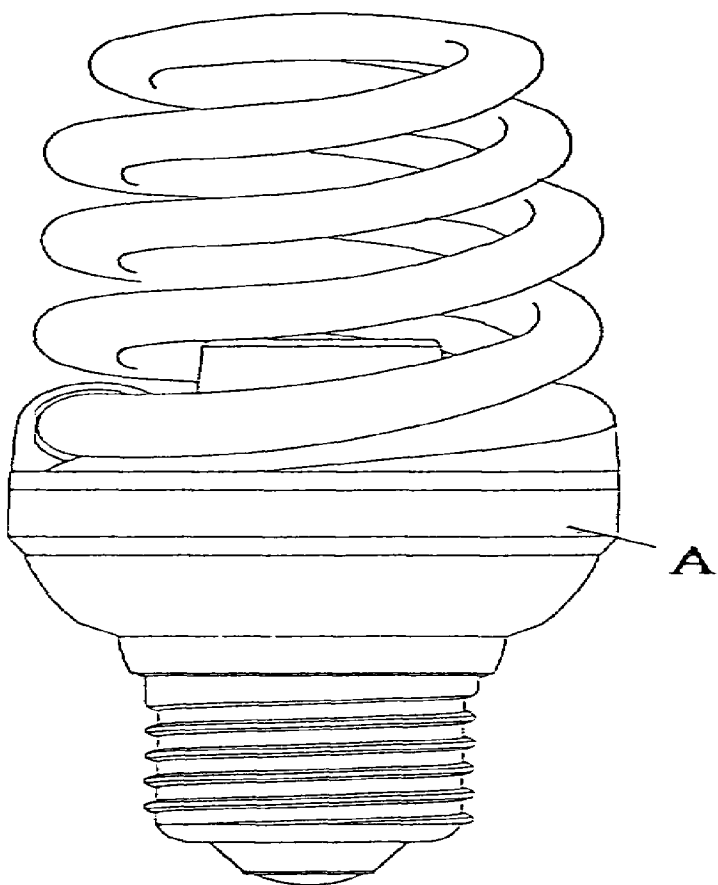

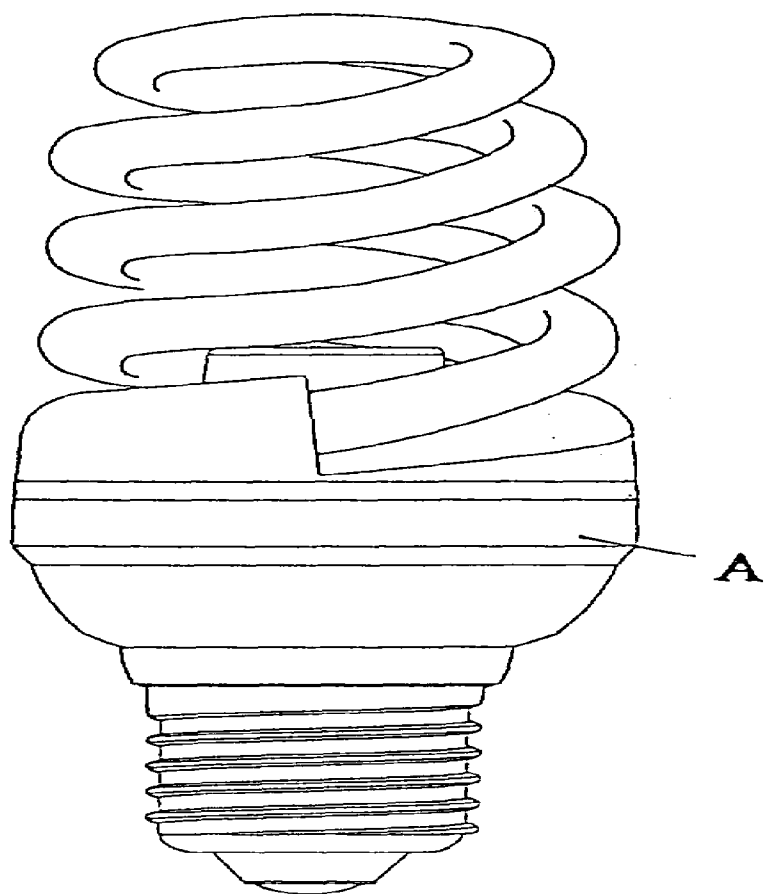

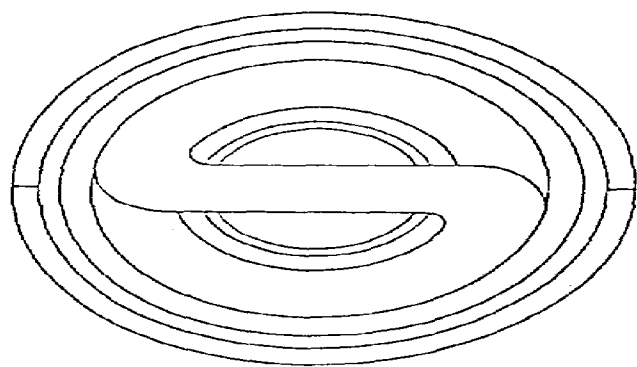
Bottom Plan View

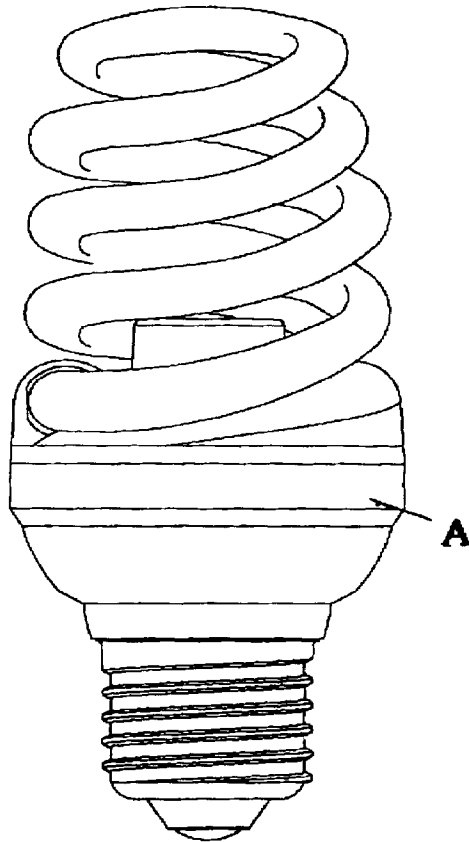

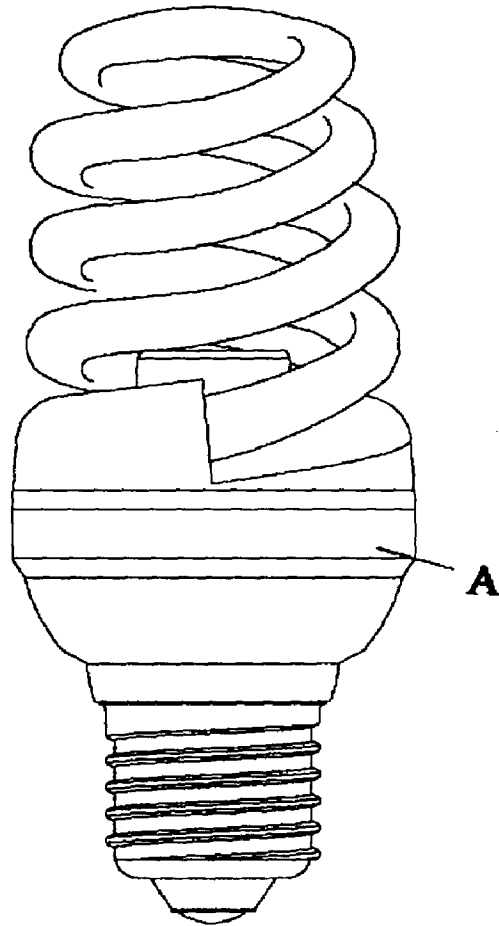

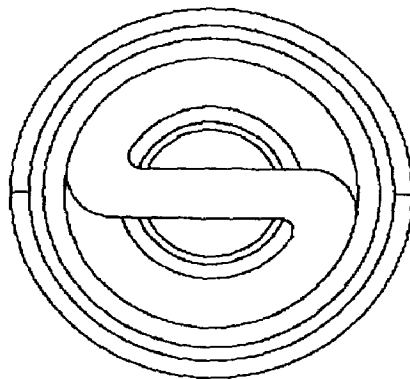
