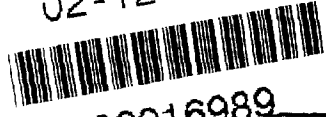

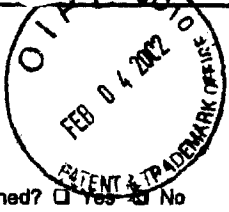

## ASSIGNMENT

WHEREAS, EX-CELL HOME FASHIONS, INC., a corporation duly organized under the laws of the State of New York, having a principal place of business at 295 fifth Avenue, New York, New York 10016 is the owner by assignment of an invention entitled Shower Curtain which is the subject of U.S. Patent Application No. 09/637,148 filed August 14, 2000; and
