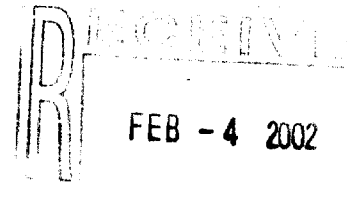



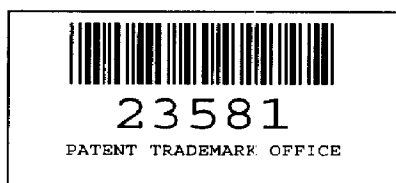

ASSIGNMENT

WHEREAS, I, Jay E. Gerow, of Bothell, county of King and state of Washington, inventor of certain improvements in a METHOD, APPARATUS AND GAMING SET FOR USE IN A PROGRESSIVE GAME, for which I have executed an application on August 5, 1999 and was given Serial No. 09/369,678.


WHEREAS, ZDI Gaming, Inc., a corporation of the state of Washington, having its primary place of business in Lynnwood, county of Snohomish and state of Washington, is desirous of acquiring a 50% interest therein:

NOW, THEREFORE, in consideration of the sum of Ten Dollars to me in hand paid, the receipt of which is hereby acknowledged, and for other good and valuable consideration, I, Jay E. Gerow, have sold, assigned and transferred, and by these presents do sell, assign and transfer to ZDI Gaming, Inc., a 50% interest in and to the invention in the United States and its territorial possessions and in all foreign countries and a 50% interest in and to any and all Letters Patent which may be granted therefor in the United States and its territorial possessions in any and all foreign countries and in and to any and all divisions, reissues, continuations and extensions thereof.

I hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to me and ZDI Gaming, Inc., as the assignee of my 50% interest right, title and interest in and to the same, for the use of ZDI Gaming, Inc., its successors and assigns.

Further, I agree that I will communicate to ZDI Gaming, Inc. or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue application, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to me and to ZDI Gaming, Inc., make all rightful oaths and generally to do everything possible to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
