PATENT ASSIGNMENT

WHEREAS, ObjectSpace, Inc. (hereafter "Assignor"), a Delaware corporation, having an address of 14850 Quorum Drive, Suite 500, Dallas, Texas 75240, is the owner of U.S. Patent Application Serial No. 09/451,497 filed November 30, 1999 and entitled *System and Method for Communications in a Distributed Computing Environment*; and

WHEREAS, Recursion Software, Inc. (hereafter "Assignee"), a Texas corporation, having an address of 2591 North Dallas Parkway, Suite 200, Frisco, Texas 75034, desires to acquire all right, title and interest in and to U.S. Patent Application Serial No. 09/451,497 and any Letters Patent that may issue thereon;

Assignor also assigns unto Assignee all claims for damages by reason of infringement prior to the assignment date of the Patent Property throughout the world, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignor also will communicate to Assignee any facts known to it respecting any improvements; and, at the expense of Assignee, will testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said Patent Property in all countries.
