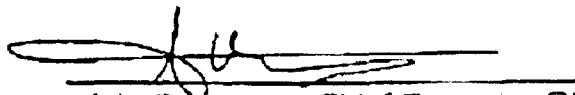
1. He is the duly elected and acting Chief Executive Officer of Unwired Planet, Inc., a Delaware corporation.
