ASSIGNMENT OF PATENT RIGHTS

This Assignment of Patent Rights is made by and between ROBERT J. MORIARTY, a resident of Monson, in the County of Hampden and Commonwealth of Massachusetts hereinafter referred to as "Assignor" and R & C ASSOCIATES, LLC, a Limited Liability Company having a place of business at Monson, Massachusetts hereinafter referred to as "Assignee". In consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration paid to the Assignor by the Assignee, the Assignor and the Assignee hereby agree as follows:

1. The Assignor agrees to execute all documents necessary in connection with this Assignment and to file this Assignment with the United States Patent and Trademark Office as required by 35 U.S.C. 261 and 37 C.F.R. §1.331 and to pay the required assignment fee to the United States Patent and Trademark Office as set forth in 37 C.F.R. §1.21(h);
3. The Assignor states that the Patent has been maintained by the payment of the appropriate maintenance fees by the Assignor to the Patent and Trademark Office. The Assignee agrees to continue to maintain the Patent by prompt and timely payment of maintenance fees to the United States Patent and Trademark Office pursuant to 37 C.F.R. §1.362 and to perform all affirmative acts which may be necessary to maintain the Patent;
4. The Assignor and the Assignee hereby authorize and request the Commissioner of Patents and Trademarks and all equivalent foreign officials, to record this Assignment pursuant to 37 C.F.R. §1.332 and that the Assignor has full right to convey its entire interest herein assigned, and that the Assignor shall not and has not executed and will not execute any agreement in conflict herewith.




