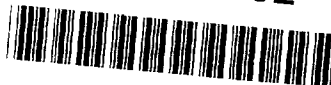



FURTHER, I agree that I will communicate to said Carlisle FoodService Products, Incorporated, or its representatives, any facts known to me respecting said invention, and testify in


