## CONDITIONAL ASSIGNMENT

Whereas, I, Fidel Lopez, a citizen of U.S., residing at 6103 S. W. 137th Court, Kendall, Florida 33183, did obtain Letters Patent of the United States of America for "UNIVERSAL KEY HOLDER WITH LIGHT", which Letters Patent is numbered 6,164,795 and bear the date of December 26, 2000; and

Whereas, I, Fidel Lopez, am the sole and exclusive owner of said Letters Patent and the invention described and claimed therein, and of all rights in, to and under the same; and

Whereas, Alliance New Products Enterprises, Inc., a Florida Corporation having its principal place of business at 1317 Canary Island Drive, Weston, Florida 33327, is desirous of acquiring the entire right, title and interest in and to said Letters Patent;

Now, therefore, in consideration for the promises and monies exchanged by the parties, and other good and valuable consideration, the receipt of which is hereby acknowledged, it is agreed as follows:

1. I, Fidel Lopez, have sold, assigned, transferred and set over to Alliance New Products Enterprises, Inc., the said invention and the Letters Patent aforesaid and any reissue of said Letters Patent, the same to be held and enjoyed by the said Alliance New Products Enterprises, Inc., for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term

- Alliance New Products Enterprises, Inc. shall pay Fidel 2. Lopez, upon the execution of this agreement, the amount of \$10,000.00 (TEN THOUSAND DOLLARS) and 60 (SIXTY) days after Alliance New Products Enterprises manufactures a prototype incorporating said invention, and notifies Fidel Lopez, the latter shall receive another \$10,000.00 (TEN THOUSAND DOLLARS) from Alliance New Products Enterprises, Inc. Alliance New Products Enterprises, Inc. shall manufacture said prototype within the next (5) five years from the date of this agreement.
- In the event that Fidel Lopez is not paid said second payment 3. of \$10,000.00 (TEN THOUSAND DOLLARS) within (60) sixty days from the date the prototype is manufactured, this assignment agreement shall be null and void, and the patent rights shall revert back to Fidel Lopez.
- Any controversy or claim arising out of or relating to this 4. contract, or the breach thereof, shall be settled by one arbitrator and the proceedings administered by the American Arbitration Association under


