

PATENT ASSIGNMENT

TO HAVE AND TO HOLD the same unto its successors and assigns, to the full end of the term for which said Patents are granted.

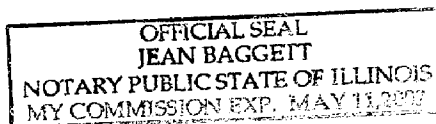
