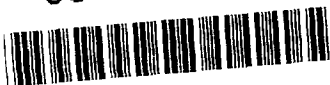

## ASSIGNMENT

WHEREAS, WE, **Ronald K. Eyre, Madapusi K. Keshavan and David Truax**, residing at
