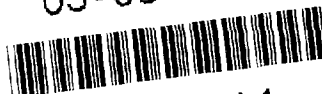


ASSIGNMENT OF DESIGN PATENT
