ASSIGNMENT

WHEREAS, I, Daniel L. Gysling, a citizen of the United States, and residing at 763 Chestnut Hill Road, Glastonbury, Connecticut, and Mark R. Myers, a citizen of the United States, and residing at 99 Hillydale Road, Storrs, Connecticut, having invented certain improvements in a METHOD AND APPARATUS FOR DETERMINING COMPONENT FLOW RATES FOR A MULTIPHASE FLOW, which is described in an application for Letters Patent of the United States, Serial No. 09/996,626, filed November 28, 2001, and identified by Ware Fressola, Van Der Sluys & Adolphson LLP/CiDRA/Weatherford International as file nos. 753-001.002/7CC-0184/COS-3778, and being owner of all right, title and interest in and to said application and in and to any invention described therein, free from all prior assignments, agreements, licenses, mortgages, or other encumbrances whatsoever, and having full right to convey the entire interest both legal and equitable herein assigned; and

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged by the undersigned, the undersigned does hereby sell, assign, transfer and set over unto said assignee, its successors and assigns, the entire right, title and interest in and to said invention or inventions, as described in the aforesaid U.S. Patent application, in any form or embodiment thereof, and in and to the aforesaid application; and in and to any application filed in any foreign country based thereon, including the right to file said foreign applications under the provisions of the International Convention; also the entire right, title and interest in and to any and all patents or reissues or extensions thereof to be obtained in this or any foreign country upon said invention or inventions and any divisional, continuation, continuation-in-part or substitute applications which may be filed upon said invention or inventions in this or any foreign country; and the undersigned hereby authorizes and requests the issuing authority to issue any and all patents on said application or applications to said assignee or its successors and assigns.

The undersigned further agrees, without any further payment or compensation by said assignee or its successors and assigns, to communicate to said assignee, its representatives or agents or its successors and assigns, any facts relating to said invention or inventions including evidence for interference purposes or for other legal proceedings whenever requested; testify in any interference or other legal proceedings, whenever requested; execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective; and generally do everything possible to aid said assignee, its successors or assigns and nominees to obtain and enforce proper patent protection for said invention or inventions in this or any foreign country.

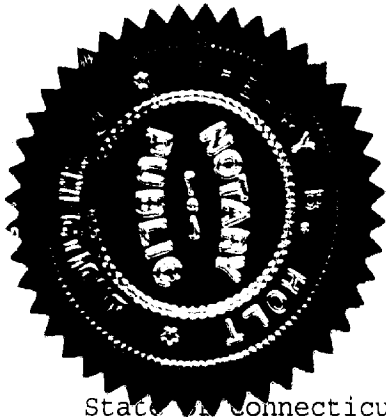
