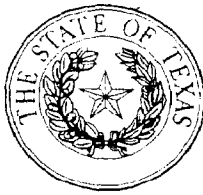

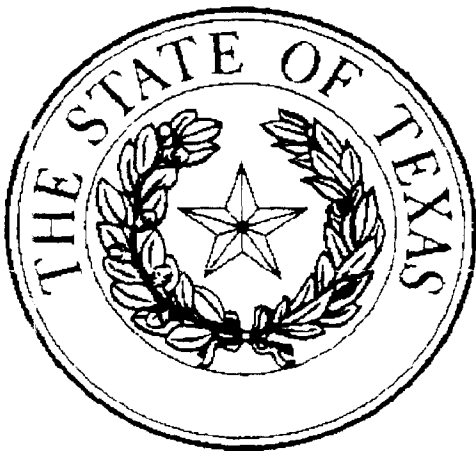

Corporations Section

I.

The current name of the corporation is HERZ TECHNOLOGIES INCORPORATED.

II.

Article I of the Articles of Incorporation is hereby amended to read:

"I.

The name of the corporation is PINPOINT INCORPORATED."

III.

These Articles of Amendment to the Articles of Incorporation of Herz Technologies Incorporated were adopted by a vote of at least two thirds of the Shareholders on 9 March 2001.
