And I hereby authorize the Commissioner of Patents to issue any and all Letters Patent of the United States of America for said invention, or resulting from said application or applications therefor, to the said **AKZO NOBEL N.V.**, as the assignee of the entire right, title and interest in and to the said application and invention.
