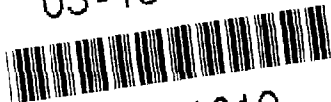

ASSIGNMENT




