A S S I G N M E N T

WHEREAS, WE, DANIEL Philippe, GOULAY Pascal and MONTEIL Pascal, citizens of the French Republic, residing respectively at : 1 rue du Maréchal de Rochambeau, 41100 VENDÔME, FRANCE ; 390 Boulevard Roosevelt, 41100 VENDÔME, FRANCE ; and 4 Faubourg St Lubin, 41100 VENDÔME , FRANCE - have invented new and useful improvements in :

"ASSEMBLING A STEERING COLUMN BRACKET WITH A STEERING GEAR OF AN AUTOMOBILE VEHICLE"

for which WE have executed an Application for Letters Patent of the United States on :

WHEREAS, NACAM FRANCE SA, a body corporate organized and existing under the laws of the Republic of France and having a place of business at Z.I. NOW, THEREFORE, in consideration of the sum of one dollar (\$ 1.00) to us in hand paid, the receipt of which is hereby acknowledged, WE, the said DANIEL Philippe, GOULAY Pascal and MONTEIL Pascal have sold, assigned, transferred and set over to NACAM FRANCE SA and do hereby sell, assign, transfer and set over to its successors, legal representatives and assign, the entire right, title and interest to and under the said improvements, and the said Application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and WE authorize and request the Commissioner of Patents of the United States to issue all Letters Patent for said improvements to NACAM FRANCE SA, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that WE have full right to convey the entire interest herein assigned, and WE have not executed and will not execute any agreement in conflict therewith.

AND WE HEREBY further covenant and agree that WE will communicate to the said NACAM FRANCE SA, its successors, legal representatives and assigns, any fact known to us respecting all lawful papers, execute all divisional, continue and reissue applications, make all rightful oaths, and generally do everything possible to aid the said body corporate, its successors, legal representatives and assigns, to obtain and enforce proper protection for said improvements in the United States.




