ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, we, NIKO EIDEN and KIMMO HÄMYNEN, citizen(s) of Germany and Finland, respectively, and residing at Agricolankatu 11B15, 00530 Helsinki, Finland and Kuunsäde 10 A 2, 02210 Espoo, Finland, respectively, hereby sell, assign and transfer to NOKIA CORPORATION, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in SYSTEM FOR PROTECTING PICTURES USED IN WIRELESS COMMUNICATION MESSAGES, which is described in an application for Letters Patent of the United States, Serial No. 10/023,438, filed December 18, 2001; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We authorize and empower the said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from us.


We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be




