NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNORS, by these presents do sell, assign, and transfer to ASSIGNEE, and its successors, assigns and legal representatives the full and exclusive right, title and interest in and to the '195 patent, and all corresponding foreign patent and patent applications, all divisional, continuation, continuation-in-part, reissue and reexamination applications to the '195 patent, and all Letters Patent or comparable rights to the '195 patent issuing thereon in the United States and in all foreign countries, together with the right of priority under the International Convention of the Protection of Industrial Models, and any other international agreements to which the United States of America adheres;

ASSIGNORS give full authorization to ASSIGNEE to make application for such protection of the '195 patent in its own name and maintain such protection in all foreign countries, and according to any international agreements to which the United States of America adheres and to invoke and claim for any application for patent or other form of protection for the '195 patent, without further authorization from ASSIGNEE;




