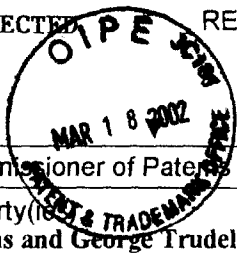

## ASSIGNMENT
