WHEREAS, we, Christoph Manusch, Wulf Herrmannsen and Olaf Balke citizens of Germany and residents of Berliner Strasse 8b, 30966 Hemmingen, Germany; Rebhuhnweg 16, 30952 Ronnenberg, Germany and Hindenburg Strasse 37, 31515 Wunstorf, Germany; respectively, have invented certain new and useful improvement in A SLIPPING CLUTCH FOR THE TORQUE-LIMITING TRANSMISSION OF FORCE BETWEEN A SPOOL CORE OF A SPOOL FOR THE WINDING AND UNWINDING OF A TAPE AND A ROTARY SUPPORT for which we have made application for United States Letters Patent, said application having been filed as PCT international application number PCT/EP97/00653 on February 13, 1997 designating the United States of America; and various other countries; and

AND, we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may issue upon said invention to said Pritt as assignee of the entire right, title and interest in and to said invention, said application and any and all Letters Patent that may issue thereupon.
