

ASSIGNMENT

WHEREAS, I, Richard B. Manville, of Los Angeles, County of Los Angeles, State of California, have invented certain improvements in a DESIGN CRAFT KIT CONSTRUCTION COMPONENT – SERPENTINE WORM FORM, for which I have executed an application for Letters Patent of the United States on the date I executed this Assignment as hereinafter set forth.
