## ASSIGNMENT

I, Michael G. Lotz of 1085 Falcon Court, Louisville, Colorado, 80027, have co-invented a method and apparatus entitled **SYSTEMS AND METHODS FOR MIGRATION AND RECALL OF DATA FROM BETWEEN LOCAL AND REMOTE STORAGE** hereinafter called the "invention."

I hereby agree, without further consideration and without expense to me, to sign all lawful papers and to perform all other lawful acts which the Assignees or either of them may request of me to make this Assignment fully effective, including, by way of example but not of limitation, the following:

Prompt execution of all original, divisional, substitute, reissue, and other United States and foreign patent applications on said invention, and all lawful documents requested by the Assignees or either of them to further the prosecution of any of such patent applications.

Cooperation to the best of my ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.


