Assignee like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference or reexamination which may arise involving said invention, or any application or Letters Patent herein contemplated; and that he will execute and deliver to the said Assignee any and all additional papers which may be requested by the said Assignee to fully carry out the terms of said assignment.

And the Commissioner of Patents and Trademarks is hereby authorized and requested to issue Letters Patent to the said Assignee in accordance with the terms of this assignment.
