
ASSIGNMENT



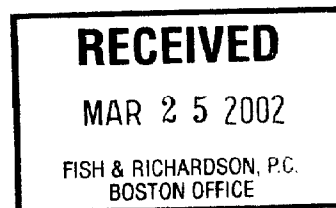
