

Assignment Contract for Patent Ownership –
Patent#5,975,411 Serial#09/182,791

This is a simple contract to transfer 100% ownership from John F. Windolph III (seller) to Frank H. Pilarcik (buyer). There will be no monies given to seller from buyer. Buyer agrees to pay seller a 25% commission on any/all monies that are earned from the sale, manufacturing or royalties that are generated from the product. This is the only compensation that seller will be entitled to from buyer. Buyer will be Responsible for all costs that are incurred to bring product to market. However, there will be no expressed or guarantees that buyer will be successful in their efforts to bring product to the market. Seller agrees to file all necessary paperwork with the U.S. Patent and Trademark Office to assign patent#5,975,411 to buyer within 10 days after receiving this contract. New ownership will become binding once all parties sign and notarize contract. Time frame for U.S.P.T. office filing will not affect new ownership for patent#5,975,411



Once seller receives all paperwork for the U.S.P.T. office they will be expressed mailed to buyer.

For purposes of this contract John F. Windolph 111 will be referred to as "seller" and Frank H. Pilarcik will be referred to as "buyer".
