ASSIGNMENT OF PATENT RIGHTS

THIS ASSIGNMENT is made this 1st day of February, 2002 by and between Surgical Acuity, Inc., a Delaware corporation (hereinafter also referred to as "Assignor"), and Kerr Corporation, a Delaware corporation (hereinafter also referred to as "Assignee").

WHEREAS, Assignor is the sole and exclusive owner of and holds good and marketable title to the issued United States and foreign patents identified at Exhibit A, attached hereto, and in and to the inventions described therein (collectively referred to as the "Issued Patents");

WHEREAS, Assignor is the sole and exclusive owner of and holds good and marketable title to the United States and foreign patent applications, international convention (e.g. PCT) applications, pending as of the date of this Assignment as identified at Exhibit B, attached hereto, and in and to the inventions described therein (collectively referred to as the "Patent Applications");

WHEREAS, Assignor is the sole and exclusive owner of and holds good and marketable title to the invention disclosures identified and described at Exhibit C, that are not yet the subject of a patent application or issued patent (unless otherwise designated) as of the date of this Assignment, and in and to the inventions described therein (collectively referred to as the "Invention Disclosures");

WHEREAS the term "Patent Rights" as hereby defined as the Issued Patents, Patent Applications, and Invention Disclosures as defined herein, alone and/or in combination, further includes any divisional, continuation, continuation-in-part, reissue, reexamination, extension, foreign, and international patent applications and patents thereof;

WHEREAS, Assignor desires to grant the entire right, title, and interest in and to the Patent Rights to Assignee, subject to the Representations and Warranties noted in the "Purchase and Sale Agreement" by and among Kerr Corporation, Surgical Acuity, Inc. and Colorado Mezzanine Fund, LTD, dated January 31, 2002.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers unto Assignee, its successors and assigns, the entire right, title and interest throughout the United States of America and the territories thereof, for all foreign countries and under all international agreements in and to said inventions, the aforesaid Patent Rights, all other applications hereafter filed in the United States, in any other country, or under any international agreement based in whole or in part on said Patent Rights, and all Letters Patents granted upon said Patent Rights by the United States, by any other country or under any international agreement, including: (i) the right to sue and collect damages for past infringements of the Patent Rights (ii) the right to sue and collect damages for future infringements of the Patent Rights; and (iii) the right to sue and collect damages for infringement of any provisional rights for any publications relating to the Patent Rights.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all Letters Patents issuing from the Patent Rights assigned hereunder to Assignee or its assigns.

Assignor further grants to Assignee, its successors and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries or between any other countries.

Assignor hereby warrants that Assignor has the full right to make the conveyance herein, and Assignor hereby covenants that

Assignor will, when requested by Assignee, communicate to Assignee, its representatives, successors and assigns, all facts known respecting the Patent Rights, execute all divisional, continuing, reissue, reexamination, domestic, and foreign or international applications relating to the Patent Rights, together with individual assignments therefor, make all rightful oaths, sign all lawful papers, with reasonable costs, other than attorney's fees, to be paid for by Assignee, testify in any legal proceedings with reasonable costs, including attorney's fees, which are approved in advance by Assignee to be paid for by Assignee and generally do everything reasonably practicable to aid Assignee in the enforcement of the Patent Rights. In addition, Assignor also agrees, when requested by Assignee, to execute all divisional, continuation, reissue, reexamination, domestic, and foreign or international applications for obtaining any subsequent patents which relate to the Patent Rights.
