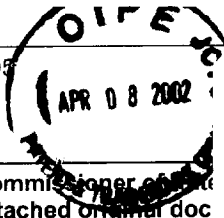

authorizes and requests the Commissioner of Patents and Trademarks of the United


States to issue all future Letters Patent which may be granted to SCHERING AG, its successors and assigns, in accordance with the terms of this Assignment.
