ASSIGNOR further covenants that ASSIGNEE will, upon request, be provided promptly with all pertinent facts and documents relating to said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and ASSIGNOR will testify to the same in any interference, litigation or proceeding related thereto, and ASSIGNOR will promptly execute and deliver to ASSIGNEE or ASSIGNEE's legal representatives any and all papers, instruments or affidavits required to maintain, issue and enforce said Letters Patent and said equivalents thereof which may be necessary or desirable to carry out the purposes thereof.

ASSIGNOR hereby consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of ASSIGNEE to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.

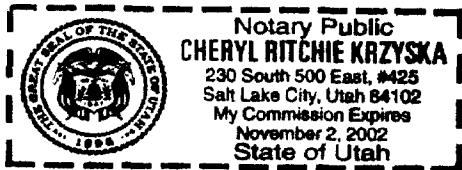
