AND THE ASSIGNORS HEREBY warrant that they have the full right to convey the interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith, and that the rights and benefits assigned hereunder are free and clear of any lien, encumbrance, adverse claim or interest, and that they have not licensed anyone under the Invention or said patent applications or patents.

AND THE ASSIGNORS HEREBY further agree to communicate to the said Assignee, its successors, legal representatives and assigns, any facts known respecting said Invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications and the like, make all rightful oaths or declarations, and generally do everything reasonable to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said Invention in all countries.

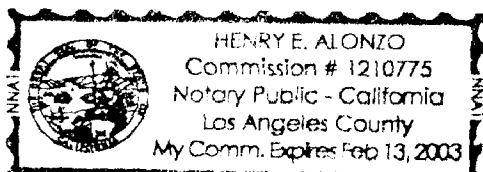
