Patentee hereby covenants that he has the full right to convey the entire interest herein assigned, and he has not executed, and will not execute, any agreement in conflict herewith.

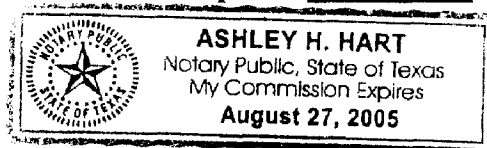


