

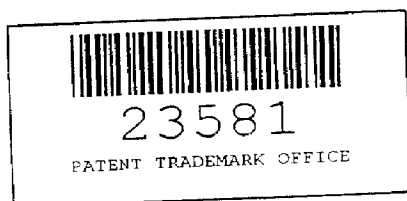

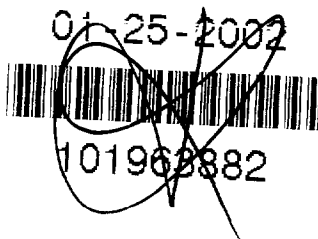

ASSIGNMENT OF PATENT

RECITALS:

A. The undersigned, ROBERT L. POLLACK, residing at 8442 Chippewa Road, Philadelphia, PA, 19128 (hereinafter referred to as "Assignor") has invented certain improvements generally related to the isolation of naturally occurring amino acids for which U.S. Patent No. 5,945,542, entitled "Isolation of Natural L-B-3-Indolylalanine and Enrichment of Natural Aliphatic Amino Acid Mixtures with Natural L-B-3 Indolylalanine," issued on August 31, 1999 (the "Patent"). The Patent issued from U.S. Patent Application Serial No. 09/303,952, which was filed February 26, 1998, and from which U.S. Patent Application No. 09/361,489 and PCT Patent Application Serial No. PCT/US99/19711 are presently pending (collectively, the "Patent Applications").

B. AMINOPATH LABS, L.L.C., a limited liability company organized and existing under the laws of the State of Oregon and having an office for the transaction of business at 970 Columbia Blvd., St. Helens, Oregon, 97051, ("Assignee") desires to obtain all of Assignor's right, title and interest in and to such invention, the Patent and the Patent Applications. Assignor desires to assign such right, title and interest to Assignee.

NOW, THEREFORE, the parties hereby agree as follows:

3. **Future Acts.** Assignor does hereby covenant and agree that he, including his lawful legal representatives, successors and assigns, shall not execute any writing or do any act whatsoever conflicting with this Assignment and upon request and without further or additional consideration, but at the expense Assignee, will execute and deliver such additional assignments, instruments, applications, papers, affidavits, powers of attorney or other writings and perform such further or additional acts as Assignee may deem necessary or desirable to effectively secure to and vest unto Assignee the entire right, title and interest set forth in this Assignment and render all necessary assistance in making further applications, continuations, divisions, renewals or substitutions thereof and in enforcing any rights accruing as a result of this Assignment.

4. **Issuance of Patent.** Assignor hereby requests the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for or in

connection with the Patent Rights to Assignee, its legal representatives, successors, or assigns, as the owner of the entire right, title, and interest of Assignor in and to said Patent Rights.
