

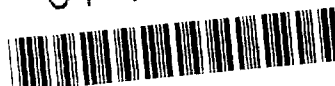



**ASSIGNOR** hereby covenants that no assignment, sale agreement or encumbrance has been made or will be made or entered into which would conflict with this Assignment.


