ASSIGNMENT

This Assignment made by me, **Peter Laaser**, hereinafter referred to as assignor, a citizen of Germany, residing at Rablstrasse 12, City of Munich, Germany;

WITNESSETH: That,

WHEREAS, I am the sole inventor of certain new and useful improvements in **SIGMA-DELTA A/D CONVERTER**, for which I have applied for Letters Patent of the United States on February 4, 2002, Application Serial Number 10/067,099; and

WHEREAS, **Infineon Technologies AG**, a corporation duly organized and existing under the laws of Germany and having a principal place of business at St.-Martin-Str. 53, City of Munich, Germany, hereinafter referred to as assignee, is desirous of acquiring the entire right, title and interest in and to said invention as described in the specification executed by me concurrently herewith, and any and all Letters Patent which shall be granted therefor;

I hereby request the Commissioner for Patents to issue the Letters Patent in accordance with this instrument.

For the consideration aforesaid, I have sold, assigned, transferred and set over, and by these presents do sell, assign, transfer and set over, unto the said assignee, its successors, assigns or nominee, the entire right, title and interest in and to any and all Letters Patent for said invention which may be granted in countries foreign to the United States and in and to any applications for Letters Patent which may be filed for said invention in countries foreign to the United States and in and to the invention described in said application; and I hereby authorize and empower the said assignee, its successors, assigns or nominees to apply for Letters Patent or
