DESIGN PATENT ASSIGNMENT

However, in the event CENTRIX, INC. becomes insolvent, bankrupt, or ceases to do business prior to any subsequent assignment by CENTRIX, INC. of the invention and/or any patents granted therefor to a third party, rights to the invention and/or any patents granted therefor shall revert back to the inventor upon the happening thereof.
