

## ASSIGNMENT

WHEREAS, I, JUN TIAN, of Tualatin, State of Oregon, have invented a certain invention, entitled CONTENT AUTHENTICATION AND RECOVERY USING DIGITAL WATERMARKS, for which I have made application for Letters Patent of the United States, said application having been filed by me on October 18, 2001, and assigned application no. 10/035,830; and
