ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, we, KEVIN W. HAULK and CHERYL K. HARKINS, of Griffin, GA and Lawrenceville, GA, respectively, have invented certain new and useful improvements in METHODS AND APPARATUS FOR AUTOMATIC ASSIGNMENT OF A COMMUNICATION BASE STATION AND TIMESLOT FOR AN ELECTRONIC SHELF LABEL, Docket No. 9874.00, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and
