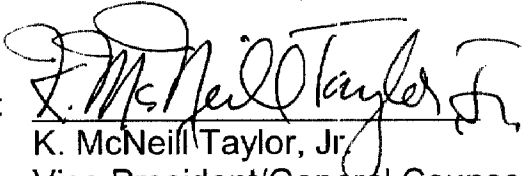

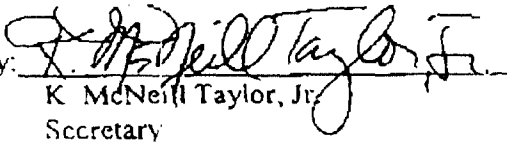
**FIRST:** Effective June 1, 2000, Article FIRST is deleted in its entirety and the following new Article FIRST is inserted in its place:
