ASSIGNMENT AND AGREEMENT



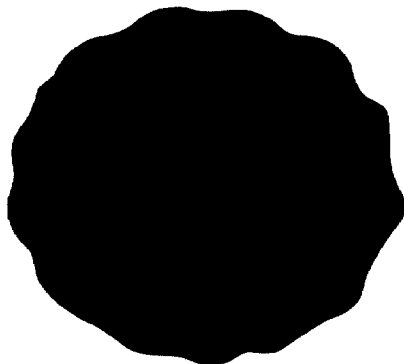

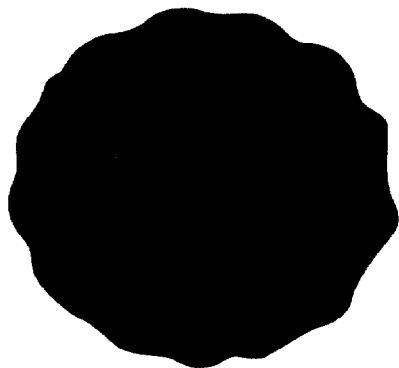
