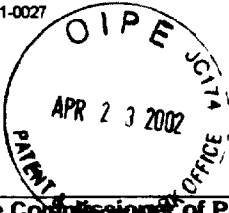




foreign countries, and in and to any and all divisions, reissues, continuations and extensions thereof.
