Declaration and Assignment

WHEREAS, we, Berthold Engels, of Parkweg 7, D-67256 Weisenheim/Sand, Germany, Arno Forster, of Landgrafenstrasse 4, D-67549 Worms, Germany, Robert Lingenauber, of Ludwig-Wolker-Strasse 17, D-67227 Frankenthal, Germany, and Jens-Wolf Jaisle, Schelklystrasse 64, D-69126 Heidelberg, Germany, have invented a MULTI-FLUTED CONTROLLABLE EXHAUST GAS-DRIVEN TURBO-CHARGER, for which we have filed a German Application, No. 19924228.3 on May 27, 1999, and a corresponding International (P.C.T.) Application on May 24, 2000; and

WHEREAS, BORGWARNER INC, a corporation duly organized and existing under and by virtue of the laws of the State of Delaware, having a place of business at 3001 West Big Beaver Road, Suite 200, Troy, Michigan 48007-5060, US, is desirous of acquiring its rights in and to said invention and any Letters Patent to issue therefor subject to German law;

We agree to execute any and all documents required by said company, its successors or assigns, for the prosecution of said application, or of any division, reissue or continuation thereof, or for securing foreign patents covering said invention, and also any documents required by it, its successors or assigns, more

fully to vest in it or them the title to said invention, or to any application or patent that may be filed therefor or secured thereon.
