

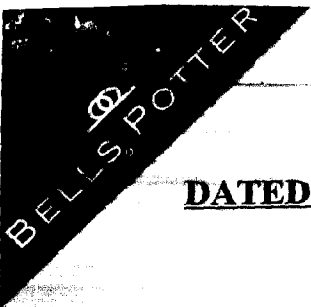

THIS DEED OF ASSIGNMENT is made the 12<sup>th</sup> day of November 1999

**BETWEEN:**

- (1) ANGEL HANDLES (INTERNATIONAL) LIMITED (registered no 2921353) whose registered office is at 1 High Street Guildford Surrey GU2 5HP ('the Assignor')
- (2) LINDA ANNE GOTTING of 47 Whitmore Green Farnham Surrey GU9 9AF ('the Assignee')

**WHEREAS:**

- (A) This deed is supplemental to an agreement of even date between the parties to this deed ('the Agreement') pursuant to which the Assignor agreed to sell and the Assignee agreed to buy the Business of the Assignor as defined in the Agreement
- (B) Pursuant to the terms of the Agreement the Assignor has agreed to assign to the Assignee with full title guarantee free from all charges liens encumbrances or adverse claims all rights title and interest in the Intellectual Property Rights (as defined in the Agreement and listed at the Schedule hereto) on the terms set out below

**IT IS AGREED** as follows:

- 1 In this deed and recitals the words shall have the same meaning given to them in the Agreement
- 2 In pursuance of the Agreement and in consideration of the sum of £1.00 now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor does HEREBY ASSIGN and transfer with full title guarantee all right title and interest in the Intellectual Property Rights, including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action, to the Assignee.
- 3 The Assignor confirms that this assignment is made with the goodwill attaching to the Intellectual Property Rights and the goodwill of the business in which the Intellectual Property Rights have been used by the Assignor.
- 4 The Assignor warrants to the Assignee as follows in respect of each of the registered Intellectual Property Rights:
  - 4.1 that all renewal fees due in respect of the registrations have been paid;
  - 4.2 that the Assignor has appointed no licensees of any of them nor given any other person any permission to use any of them;
  - 4.3 that the Assignor is unaware of any infringement of the registration of any of them or of any reason why any registration may be capable of being expunged from the register for any reason whatsoever;
  - 4.4 that there are no circumstances known to the Assignor arising out of this or any earlier assignment which may result in the use of the Intellectual Property Rights being liable to mislead the public;

that all previous assignments of the Intellectual Property Rights are valid, and that the assignor is properly entered on any applicable registers of Intellectual Property Rights as proprietor of the registrations.

5 The Assignor shall do and execute or procure that there shall be done and executed all such documents deeds matters acts and things as the Assignee may at any time reasonably require properly in order to vest the Intellectual Property Rights in the Assignee.

6 It is hereby certified that this transaction does not form part of a larger transaction or series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration involved exceeds £60,000 (sixty thousand pounds)

7 This deed shall be governed by and construed in accordance with English law


