## ASSIGNMENT OF PATENT APPLICATION

**THIS ASSIGNMENT OF PATENT APPLICATION** (hereinafter referred to as the "Assignment") is entered into as to the 31 day of March, 2002 by and between **CHRISTOPHER PEDICINI**, an individual resident of the state of Georgia and **JOHN D. 1. **Assignment of Rights.** In consideration of the sum of One Hundred Dollars (\$100.00) and other good and valuable consideration, the receipt and sufficient of which is hereby acknowledged, the Assignors hereby sell, assign and transfer to Assignee the full and exclusive right to the invention set forth in the Application and the entire right, title and interest in and to any and all patents which may be granted therefore. The Assignors hereby authorize and request the Commissioner of Patent and Trademarks to issue said United States Patent to the Assignee, of the entire right, title and interest in and to the same, for its sole use and benefit and that of its successors and assigns, and for the full end of the term for which said Patent may be granted, as fully and entirely as the same would have been held by Assignors had this Assignment not been made.

2. **Representation of Assignees.** Assignees hereby warrant that Assignees are the sole owners of the Application and the invention thereto and warrant that the following information is true and correct as it relates to the Application:

- (a) The Application was executed by Assignors on March 1, 2002;
- (b) The names of the inventors are Christopher S. Pedicini and John D. Witzigreuter; and
- (c) The title of the Application is "Portable Electrical Motor Driven Nail Gun."

5. **Governing Law.** This Assignment shall be construed according to the laws of the State of Georgia.


6. **Entire Agreement.** This Assignment sets forth the entire understanding and agreement between the parties with reference to the subject matter hereof.


