## **PATENT ASSIGNMENT**

Assignor covenants that Assignor has the full right to convey the interest assigned by the Assignment, subject to the CIT Security Interest, and Assignor will not execute any agreement in conflict with this Assignment. Assignee acknowledges and accepts the assignment subject to the CIT Security Interest.

This Assignment shall be effective on the date it is signed by Assignor. The undersigned representatives of Assignor and Assignee are officers of the respective companies with authority to bind their respective companies to the terms of this Assignment.




