


RELEASE OF SECURITY INTEREST

This is an agreement among Arichell Technologies, Inc., a Massachusetts corporation having a principal place of business at 55 Border Street, West Newton, Massachusetts 02165 ("Arichell"), Bank of America National Trust and Savings Association f/k/a Bank of America Illinois, having an office at 231 South LaSalle Street, Chicago, Illinois 60697 ("BA"), and Sloan Valve Company, an Illinois corporation having an office at 10500 Seymour Avenue, Franklin Park, Illinois 60130 ("Sloan").

WHEREAS Arichell has conveyed to BA and Sloan, by way of a security agreement dated April 24, 1996, (as amended and reaffirmed on December 2, 1996, the "Security Agreement"), security interests in the intellectual property listed in attached Schedule A (together with any other patents and patent applications in which rights were thereby conveyed, "the Patents") to secure a loan made by BA to Arichell and to secure a guaranty of Sloan for said loan by way of a Guaranty dated April 24, 1996 (as subsequently amended and restated on December 2, 1996, the "Guaranty"); and

WHEREAS Arichell has contemporaneously herewith refinanced the loan;

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. BA and Sloan hereby terminate the Security Agreement.

2. BA and Sloan hereby release their respective security interests in and mortgages on the Patents, assign to Arichell their entire right, title, and interest therein, and agree to perform all acts and execute all documents reasonably required to perfect or record that release and assignment.


In testimony whereof we have executed this Agreement as an instrument under seal on the dates indicated next to our names.






