WHEREAS, MARIO MALIZIA (hereinafter "the Assignor"), a citizen of Italy residing at Via Berardi 19, 60022, Castelfidardo, (MC) Italy, has invented certain new and useful improvements in ADJUSTABLE SUPPORT APPARATUS for which an application for United States Letters Patent (Serial No. 10/052,782) was filed on January 18, 2002, and

Assignor hereby authorizes the Assignee and its successors to apply for a patent or patents directly in its own name upon the aforesaid invention wherever the same is permitted by law, and also assigns, sells, transfers and sets over unto the Assignee and its successors all priority rights under the aforesaid application.

Assignor further covenants to execute all additional instruments and to do all things necessary to carry out the purpose of this instrument, at the expense of the Assignee and its successors.
